

Creating scholarships is EASY!

1. Determine the dollar amount.

Your limit to take as a tax credit is your state tax liability or the maximums set by the state.

The maximums are:

2019 Tax Year -

\$2,269 filing jointly & \$1,135 filing single.

2020 Tax Year -

\$2,365 filing jointly & \$1,183 filing single.

2. Determine if you would like to recommend a child or school.

Although Arizona law prevents us from using the recommendation as the only consideration when awarding scholarships, we do use it as one of the primary considerations.

3. Make your donation.

To donate, you can send in this form, go to our secure website, or you can call us.

4. Take the credit.

Take your donation as a dollar for dollar tax credit on your Arizona State taxes by giving the receipt to your tax advisor, or by following the instructions we can provide for turbo tax and other tax software programs.

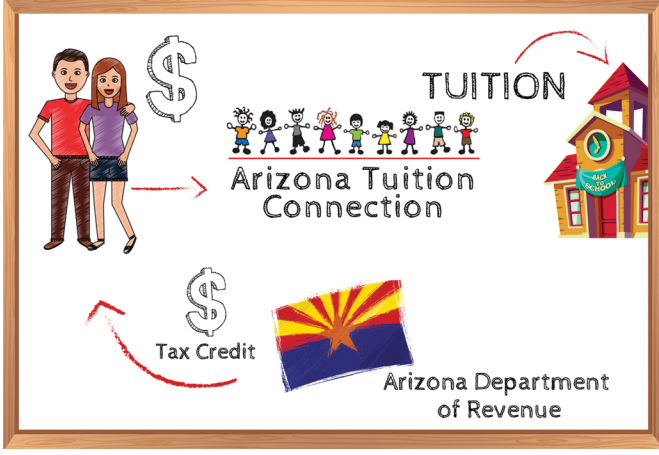
