Individuals make tax credit donations to Arizona Tuition Connection. Donors can recommend a student to receive the funds.



Arizona Tuition Connection turns those funds into scholarships!



Scholarships are awarded to schools for specific students.



The student's tuition is reduced by the amount of the scholarship. There is no limit to the number of donations a student can be recommended to receive. 100% of the tuition can be covered!



The donor claims a dollar-for-dollar credit off their Arizona state taxes. The net cost to the donor is ZERO!

**Join us at one of our many parent coaching sessions!** This is the single best way to educate yourself on the tax credit program.


