#### **DONATION GUIDELINES**

- Maximum donation amounts for the 2023 tax year:
  - Married filing jointly: \$2,609
  - Filing single: \$1,307
  - Or your tax liability, whichever is less.
- Donations can be made through April 15th, 2024 for the 2023 tax year.

#### TAKING THE CREDIT

- Your receipt will have the information needed for your taxes.
- Donations are claimed on forms 323 and 348.
